



## PRIZE DRAW RULES and TERMS AND CONDITIONS FOR PARTICIPATION

### "LET'S GO TO ČATEŽ – TO CELEBRATE"

The organiser of the prize draw "LET'S GO TO ČATEŽ – TO CELEBRATE" is the company Terme Čatež d.d. (hereinafter: **the "Organiser"**), Topliška cesta 35, 8250 Brežice, Slovenia, VAT ID: SI 55444946.

**Terme Čatež d.d., Topliška cesta 35, 8250 Brežice, Slovenia, VAT ID: SI 55444946** also participates in the prize draw as a sponsor of the prize draw (hereinafter: **the "Sponsor"**).

#### 1. Duration and Location of the Prize Draw

The prize draw will take place on the official Facebook profile of Terme Čatež **from April 22, 2025 to and including June 18, 2025**. Participation in the Facebook prize draw is a condition for entry (participants must follow the official Facebook profile of Terme Čatež, "like" the prize draw image, comment with their favourite memory from Terme Čatež, and tag the person they would like to attend the 100th anniversary celebration of Terme Čatež with), **and** purchase an e-ticket between 22 April 2025 and 18 June 2025 (inclusive) to attend the event celebrating the 100th anniversary of Terme Čatež, which will take place on 21 June 2025 at the Summer Thermal Riviera.

The drawing of ten shortlisted winners for the 10 TOP prizes will be held on Thursday, 19 June 2025. The final draw and prize distribution will take place at the event itself on Saturday, June 21, 2025.

To claim the prize, the winner/winning ticket holder is required to attend the celebration of the 100th anniversary of organised tourism at Terme Čatež, which will take place at the Summer Thermal Riviera, Topliška cesta 35, 8250 Brežice, Slovenia, on 21 June 2025.

#### 2. Purpose of the Prize Draw

The prize draw is organised for the purpose of promoting the Sponsor and the event itself.

#### 3. Terms of Cooperation

All adult natural persons with permanent residence in the Republic of Slovenia, as well as citizens of European Union member states, are eligible to participate in the prize draw,

provided they are present at the celebration of the 100th anniversary of Terme Čatež, meet the conditions set out in these terms and conditions of participation, and take part in the prize draw during the time of its official duration.

Each participant may enter the prize draw only in their own name, whereas by participating, they confirm the accuracy of the personal data provided and explicitly agree to the rules of the prize draw.

Employees of the Organiser or Sponsor, as well as their immediate family members (including common-law partners) and employees of any legal entities or individuals associated with the Organiser or involved in the mentioned promotion, are not eligible to participate in the prize draw. Additionally, any other participants must not have any connection to the parties mentioned above. Any such participation will be considered invalid. If the participant drawn is in any way connected to the Organiser or Sponsor, the prize will not be awarded.

**Terms and conditions of participation** are that the participants **agree to the rules of the prize draw**. It is considered that by participating in the prize draw, the participant explicitly agrees to all the terms and conditions related to the prize draw.

#### **4. Organisation and Method of Participation in the Prize Draw**

- send a screenshot of the invitation along with your details (name, surname, email address, phone number) to the email address [info@terme-catez.si](mailto:info@terme-catez.si) with the subject "I am participating in the 100 years prize draw".

The final prize distribution will take place at the event itself on Saturday, June 21, 2025, so the individual must be present at the event to receive the prize.

Participants in the prize draw will compete for 10 prizes, which include:

- 1 x electric vehicle rental for a period of 100 days
- 1 x gold ticket for the summer or winter season at Thermal Riviera (100 entry passes)

The Organiser will notify the winners of the draw by phone or email. The Organiser will also inform winners that they have been shortlisted for the main 10 awards. The final draw will be held live at the event celebrating the 100th anniversary of Terme Čatež, on 21 June 2025. The exact time of the draw will be communicated to the winners in advance. The winners of the 5 main prizes will be called to the stage, where they will be able to collect their prizes. The participant cannot choose another person to collect the prize on their behalf. The winner is required to prove that they meet the terms and conditions for participation. If the winner does not meet these conditions, the Organiser reserves the right to conduct an additional draw and select a new winner in the same manner as defined for the original selection of the winner. If the winner does not attend the 100th anniversary celebration of Terme Čatež, the Organiser reserves the right to conduct a new draw for the winner during the event itself.

## **5. Awards**

Insofar as the winning participant meets all the terms and conditions for participating in the prize draw, the participant is entitled to receive the prize.

- 1 x electric vehicle rental for 100 days,
- 1 x golden ticket for the summer or winter season at Thermal Riviera (100 entry passes),  
1 x Family Package 100 at the refurbished Hotel Toplice – Family Inn for the entire family (100 hours of stay at Terme Čatež, i.e. 4 nights),
- 1 x gold ticket to Grand Spa Terme (10 premium entry passes to Grand Spa Terme),
- 1 x golden ticket for the Wellness Riviera (10 entry passes to the Wellness Riviera including swimming at the winter Thermal Riviera),
- 5 x family tickets (for a maximum of 5 people) for the summer or winter season at Thermal Riviera.

Prizes are awarded by the Organiser. One individual natural person may win only one prize. The Organiser shall either hand over the prize to the winner at the event venue or provide instructions for its collection. To claim the prize, the winner must provide the Organiser with all the necessary information for the delivery of the prize, i.e. their name, surname, date of birth, address, tax office, and tax number.

If necessary, a special contract or declaration of acceptance of the prize will be concluded with the prize winners. In the event that the Organiser requires additional information for the delivery of the prize, the winner undertakes to provide such information to the Organiser within 7 days of receiving the notification from the Organiser. In the event that the winner does not provide the required information within the specified timeframe, the Organiser is not obliged to award the prize to the winner. By participating in the prize game, the winner expressly acknowledges that they are aware of all tax implications related to receiving/accepting the prize and may choose not to accept the prize. In such cases, the Organiser will not award the prize, and the winner will provide the Organiser with a statement in which they renounce the prize.

## 6. Taxes and Personal Income Tax Prepayment

The organiser of the prize draw will, in accordance with the Personal Income Tax Act, calculate and pay the income tax advance on the gross value of the **cash prize**, and will pay the winner the prize amount reduced by the income tax advance. In accordance with the provisions of the Personal Income Tax Act, awarded prizes are classified as other income. The value of a prize or winnings in a prize draw that is not a game of chance, where certain knowledge, skill, or luck is required, shall not be included in the individual's tax base, provided the value of the winnings does not exceed 42 euros. The winner/prize recipient is responsible for paying any additional income tax based on the annual tax assessment. The Sponsor and Organiser are not responsible for any other tax obligations, and the winner/prize recipient is solely responsible for such tax obligations.

## **7. Responsibility**

The Organiser and Sponsor accept no responsibility for any damage resulting from the acceptance and use of the prize, which participants explicitly agree to by entering the prize draw. In the event of circumstances beyond the Organiser's control (force majeure), the Organiser may cancel the prize draw, which will be communicated through the moderator in the hall. In such cases, the Organiser and Sponsor shall not be held liable for any resulting damage.

## **8. Decommitment**

Upon receipt of the prize, or, if necessary, upon signing a separate agreement or statement of prize receipt, all obligations of the Organiser toward the winner cease. The Organiser and the Sponsor are not responsible for any costs associated with the collection of the prize. Any potential costs related to taxes, duties, or other fees arising from the acquisition of the prize shall be borne solely by the winner.

## **9. Prize Draw Rules**

By participating in the prize draw, participants confirm that they are familiar with the rules of the prize draw, explicitly agree to these rules, and also commit to acting in accordance with these rules. In the event of any disputes or ambiguities, these rules shall take precedence over any other announcements, whether in printed, electronic, or any other form.

## **10. Use of Personal Data**

By participating in this prize draw, all winners are also deemed to explicitly consent to the publication of their personal data and likeness (name, surname, and location) on the websites and social media channels of the Organiser and the Sponsor. The data of the prize draw winners are processed, unless otherwise specified in these terms and conditions, based on the acceptance of these rules, with the basis for processing being point (b) of paragraph 1. 6. Art. General Data Protection Regulation (GDPR). By participating in the prize draw, participants acknowledge that all collected personal data will be stored by the Organiser of the prize draw only for as long as necessary to award the prize. The data will be retained solely for the purpose of the prize draw (organisation and execution of the prize draw, awarding of the prize, tax processing) and will be deleted immediately after the prizes are awarded, except for the purposes of fulfilling tax regulations related to the advance payment of income tax. Data concerning the winners are kept by the Organiser. Winners of the prize draw can at any time withdraw their consent and request access, correction, or deletion of their personal data by sending their request by mail to the Organiser's address or by sending

an email to: **info@terme-catez.si**. A withdrawal of consent does not affect the lawfulness of processing based on consent before the withdrawal of consent. The supervision of personal data protection is carried out by the Information Commissioner of the Republic of Slovenia.

### **11. Complaint Resolution**

All complaints and claims are handled by the Organiser of the prize draw in cooperation with the Sponsor. In the event of justified complaints, the Organiser and the Sponsor agree to make efforts to resolve these complaints as quickly as possible and inform the participant in the prize draw accordingly.

### **12. Final Provisions**

The Organiser reserves the right to amend the rules if required by technical or commercial reasons, or reasons related to the public. For additional information, interested parties can also write to **info@terme-catez.si** (with the subject line "Regarding the Terme Čatež 2025 Prize Draw").

The contracting parties agree that any disputes arising from this prize draw will be resolved amicably. Insofar as this is not possible, the competent court in Brežice will have jurisdiction over the dispute, and Slovenian law will apply. These rules come into force on the date of acceptance.
